8. Manage the secure collection, storage, and reporting of immutable cold chain data and audit trails.
9. Understand the process of system validation and qualification for ERP cold chain features
10. Utilize ERP analytics to measure Cold Chain Key Performance Indicators (KPIs) and optimize logistics performance.
11. Select appropriate thermal packaging and refrigerated container technologies for various transport modes.
12. Assess the future role of Blockchain technology in enhancing cold chain transparency and trust.
13. Apply ERP functionality to reduce product spoilage and minimize waste, improving overall supply chain resilience.

- Case Study: A high-stakes pharmaceutical recall scenario: Participants use the ERP's recall module to identify and isolate all affected product within 4 hours.
