1. ERP Controlling Fundamentals & Master Data

- Define the role of Controlling in the ERP ecosystem and its integration with Financial Accounting (FI).
- Structure and maintain key master data.
- Understand the purpose and hierarchical arrangement of the Standard Cost Center Hierarchy.
- Map organizational units for proper cross-company reporting.
- Case Study: Designing a Cost Center structure for a multi-national manufacturing firm.

2. Planning, Budgeting, and Actual Postings

- Execute Cost Center Planning for expenses, activities, and statistical key figures.
- Perform direct and indirect Actual Postings and cost assignments to Cost Centers/Internal Orders.
- Analyze and interpret the Plan and Actual Comparison Report to monitor performance.

- Lock planning data and manage versions for effective Budget Control.
- Case Study: Developing the annual marketing budget and tracking spend by promotional activity.

3. Period-End Closing & Cost Allocation

- Execute period-end closing activities.
- Master advanced Allocation Cycles using Distribution and Assessment methods for overhead costs.
- Identify and correct cost object postings using Reposting and Mass Reposting tools.
- Manage the treatment of variances and under/over-absorbed costs at period close.
- Case Study: Allocating shared IT and HR service costs from central Cost Centers to operational units.

4. Internal Orders for Project Costing

- Understand Internal Orders (IOs) for temporary cost tracking
- Differentiate between real and statistical Internal Orders and their use cases.
- Manage the IO lifecycle: creation, budgeting, actual postings, and Final Settlement.
- Utilize IO reporting to track project profitability and budget consumption.
- Case Study: Tracking the full lifecycle cost of a new product development project using Internal Orders.

5. Profit Center Accounting (PCA) Essentials

- Define and structure Profit Centers for segment-based performance measurement.
- Understand the flow of data from FI and CO modules into Profit Center Accounting.
- Configure New General Ledger and Document Splitting for PCA reporting.
- Perform period-end reconciliation between FI and PCA balances.
- Case Study: Implementing Profit Centers across different geographical regions for P&L reporting.

6. Profitability Analysis (CO-PA) and Margin Reporting

- Differentiate between Costing-Based and Account-Based CO-PA in S/4HANA.
- Configure the Operating Concern and define the characteristics for analysis.
- Set up value fields/cost elements to capture revenues, costs, and deductions.
- Execute Derivation Rules to determine the correct Profitability Segment for each transaction.
- Case Study: Calculating product-level profitability by customer and sales channel after all allocations.

7. Advanced Reporting and Analysis

- Build and modify custom reports using tools like Report Painter and Report Writer.
- Utilize the ERP Information System for standard and exception-based reporting.
- Integrate ERP data with external Business Intelligence (BI) platforms for advanced analytics.
- Customize report layouts for management consumption.
- Case Study: Creating a dynamic monthly profitability dashboard for the executive team with KPIs.

8. ERP Implementation and Best Practices

- Review system integration points between Controlling, Logistics, and Finance.
- Discuss Best Practices for data governance and master data consistency.
- Understand the impact of Digital Transformation on controlling processes.
- Address common troubleshooting scenarios in cost allocation and profitability reporting.
- Case Study: Reviewing the system blueprint for a successful 'go-live' of the Controlling module at a major retailer.
