Module 1: Introduction to Open Source GIS and Conservation

- Navigating the QGIS interface and basic map creation.
- **Case Study:** Mapping global biodiversity hotspots and protected areas to understand conservation needs.

Module 2: Geospatial Data Acquisition and Management

- Sourcing open-source geospatial data (e.g., OpenStreetMap, Landsat, Sentinel).
- Working with GPS data from field surveys.
