Module 2: The FSC Chain of Custody (CoC) Standard

- Master the process of material input control and separation of certified from non-certified products.
- Examine the use of the FSC trademark and label on products.
- **Case Study:** How a global furniture manufacturer transitioned to a 100% FSC-certified supply chain.

Module 3: FSC Auditing and Compliance

- Learn the principles of auditing based on ISO 19011 guidelines.
- Conduct a mock Stage 1 (readiness) and Stage 2 (main) audit.
- Identify and document non-conformities and develop corrective action plans.
- Understand the role of Assurance Services International (ASI) in the FSC system.
- **Case Study:** A mock audit of a paper mill, identifying common pitfalls and best practices for compliance.

Module 4: High Conservation Values (HCVs) and Ecosystem Services

- Define and identify the six categories of High Conservation Values.
- Learn to conduct HCV assessments and develop management plans to maintain or enhance them.
- Explore the concept of ecosystem services and their importance in forestry.
- Understand the new FSC certification for Ecosystem Services (ES) and its market potential.
- **Case Study:** Protecting critical wildlife habitats and water resources in an FSC-certified forest in Canada.

Module 5: Social and Community Aspects of FSC

- Examine FSC's core labor requirements and their alignment with ILO conventions.

- Understand the rights of Indigenous Peoples and the need for Free, Prior, and Informed Consent (FPIC).
- Develop strategies for effective stakeholder engagement with local communities and workers.
- Analyze the social benefits of FSC certification, including fair wages and working conditions.
- **Case Study:** A community forestry project in Guatemala that used FSC certification to secure land rights and economic benefits for local residents.

Module 6: Risk Assessment and Controlled Wood
