### Module 1: Introduction to Enterprise Geodatabases and Versioning Fundamentals

- **Case Study:** A municipal government planning department struggles with multiple users overwriting each other's edits on a critical zoning layer. This module will lay the foundation for understanding how versioning could prevent this.

### Module 2: Implementing Traditional Versioning

- Registering data as traditional versioned.
- Creating, managing, and deleting traditional versions.
- Understanding the version tree hierarchy and its implications.
- Editing data in traditional versions and saving edits.
- Configuring version access permissions (Public, Protected, Private).
- **Case Study:** An engineering firm managing large-scale infrastructure projects needs to track design changes over time. They will learn how to set up traditional versions for different project phases, allowing concurrent design work without affecting the "as-built" data.

### Module 3: Reconciling and Posting Edits in Traditional Versioning

- The reconcile process: detecting differences between versions.

- Manually resolving conflicts using the Conflict Manager.
- The post process: integrating child version edits into the parent.
- Automating reconcile and post operations for efficiency.

- **Case Study:** A utility company updating its network infrastructure faces frequent conflicts when multiple field crews edit the same utility lines. This module will demonstrate how to efficiently reconcile and resolve these conflicts, ensuring data consistency across the network.

#### **Module 4: Branch Versioning and Web GIS Workflows**

- Understanding the Branch Versioning model and its role in Web GIS.
- Publishing branch versioned data as web feature layers.
- Editing branch versioned data through web services.
- Reconciling and posting branch versioned edits via the Version Management Service.
- Differences in conflict resolution between traditional and branch versioning.
- **Case Study:** A state environmental agency utilizes ArcGIS Online for field data collection on protected wetlands. This module will show how branch versioning facilitates real-time updates from mobile devices while maintaining data integrity in the central geodatabase.

#### **Module 5: Geodatabase Administration and Performance Optimization**

- Database user management and role-based access control.
- Geodatabase compression and its impact on performance.
- Analyzing and optimizing geodatabase performance using geoprocessing tools.
- Maintaining geodatabase integrity: checking and repairing geodatabases.
- Best practices for database backups and recovery.
- **Case Study:** A county GIS department experiences slow performance and frequent crashes with its large parcel fabric geodatabase. Participants will apply performance optimization techniques to diagnose and resolve these issues, improving system responsiveness.

#### **Module 6: Advanced Geodatabase Behaviors: Rules and Topologies**

- Implementing attribute domains for data integrity and standardization.
- Creating and managing subtypes for categorizing features.
- Applying attribute rules (calculation, constraint, validation) for automated data quality control.
- Designing and validating geodatabase topologies to enforce spatial relationships.
- Troubleshooting topology errors and maintaining data consistency.
- **Case Study:** A city planning department needs to ensure that new building footprints adhere to specific zoning regulations. This module will demonstrate how attribute rules and topology can automate checks and flag non-compliant features during editing.

#### **Module 7: Geodatabase Archiving and Data History**

- Enabling and managing geodatabase archiving for historical tracking.
- Querying and analyzing historical data using time-enabled layers.
- Managing archive classes and data retention policies.
- Restoring previous states of data from the archive.
- Benefits of archiving for auditing, analysis, and rollback capabilities.
- **Case Study:** A natural resource agency wants to track changes in forest cover over several decades. Participants will learn how to implement archiving to maintain a complete history of land cover changes for long-term ecological monitoring and analysis.

- Creating and synchronizing replica geodatabases.

- One-way and two-way replication strategies.
- Considerations for mobile data collection and disconnected editing.

- **Case Study:** A regional emergency management agency needs to share and synchronize critical infrastructure data with several remote field offices that have intermittent internet access. This module will explore how distributed geodatabases and replication can enable seamless data flow and consistency across these disparate locations.
